President's <u>Message</u> by Bob Roden, President

We hope to see you at the annual walking tour on Saturday June 14. After an eventful and exciting year, this will be our last formal event before the summer break. We will start up again in October with our Annual General Meeting and elections.

We are a volunteer organization, and we can always use more help and fresh ideas. Some of us have served for several years on the Executive. Much as we enjoy the camaraderie, we feel the interests of the Society would be best served if we could plan to move on before passing our "best before" dates. In addition to filling jobs with ongoing responsibilities, we are also happy to welcome people on-board as "executive members without portfolio", who may be called upon to participate in specific initiatives from time to time. Attendance at monthly Executive meetings is desirable, but not mandatory. Please give some thought as to how you could contribute even a small amount of your time and talent, and let us know of any ideas you might have. And, don't be surprised if someone approaches you about getting more involved.



Change to the Membership Year Some members have found it confusing that the Society's membership year is different from the fiscal year and programme year. So, to bring everything into alignment, your Executive has decided that henceforth the membership year will run from September 1st to August 31st. When you renew your membership this fall, your card will indicate 2014-2015, and your new membership will run to August 31, 2015.



Proposed Amendments to the Society's By-Laws Two amendments to the Society's By-Laws have been proposed by your Executive (see following paragraphs for details). Each of these amendments will be debated and voted upon (separately) at the Annual General Meeting on October 1st, 2014. The full text of the Society's Constitution and By-Laws will be available at the October 1st meeting, and will be provided upon request to any members who wish to review the documents before the meeting.

By-Law Amendment #1:

We have been advised that, for security reasons, it would be desirable to implement a screening process for nominations to the Society's Executive. To facilitate such a process, we propose to add the sentence "The Nominating Committee shall receive written nominations not less than thirty (30) days in advance of the Annual General Meeting." to ByLaw V(a) and remove the sentence "Further nominations can be made from the floor, providing the nominee has agreed, in writing if absent, to accept nomination." from ByLaw V(b).

By-Law Amendment #2:

Currently, the fees for each of the membership categories are specified in the By-Laws. This means that any adjustment to the fees requires a formal notice and a By-law Amendment that has to be voted on by the membership at an AGM. We think that is unnecessarily bureaucratic. We propose to remove 5 sentences of the form "The ... fee for ... Membership shall be ... dollars (\$...). from By-Law I(a), paragraphs 1 through 5, and add a new paragraph 6, "The annual fees for categories 1, 2, and 3, and the one-time fees for categories 4 and 5 shall be reviewed and established annually by the Executive Committee".

In Sympathy We were saddened to learn that Sally Dillon passed away on April 23, 2014 at Princess Margaret Hospital after a lengthy battle with cancer. Sally had been a member of the Swansea Historical Society since 1998, and she was also a long-time member and Past-President of the Swansea Horticultural Society. A memorial was held on April 26, at the Swansea Town Hall Residences.

Wednesday October 1st, 2014, Meeting SPEAKER: Thelma Wheatley on "Scandal in Early 1900s Swansea/High Park: Eugenics, Class, Abortion, and the Institutionalization of the 'Feeble-Minded'". Thelma's talk will focus on the institution in Orillia, then called the Asylum for Idiots and Feeble-Minded. In the early 1900s, Toronto was rocked by the scandal of Ruth Dembner, a young woman from a wealthy Swansea/High Park family who lived in the High Park area and had a secret abortion from which she died.

The October 1 meeting will also include the Annual General Meeting of the Swansea Historical Society and election of Board members to serve in 2014-2015.



Wednesday November 5th, 2014, Meeting SPEAKER: Popular speaker Linda Granfield will return to Swansea to discuss "The Unknown Soldier: The World Honours Those 'Known Only to God'". At the end of the First World War, Canada and other nations had to come to terms with immense grief. Millions of soldiers had been killed. Burials were swift and 'over there'. Not every man could be identified. The creation of Tombs of the Unknowns in more than 15 countries offered the bereaved one bit of consolation. But how would the honoured 'unknown' for a nation be selected? Join us and see at this illustrated presentation.



Wednesday December 3rd, 2014, Meeting SPEAKER: Nate Hendley on the story of Edwin Alonzo Boyd, the "gentleman bank robber" and leader of the notorious "Boyd Gang" which made front-page news in Toronto in the 1950s. The gang's exploits included a string of bank robberies, the murder of a Toronto police officer, and two daring escapes from Toronto's Don Jail. Two members of the gang were among the last persons to be hanged in the Don Jail.
