

If you attended the October 7, 2015, Annual General Meeting, you will already know of recent developments concerning the Society's Executive. For those members who were not at the AGM, I wish to take this opportunity to bring you up to date.

At the AGM, Marilyn and Wallace Boustead, Richard Fogel, Lance Gleich, Marjorie Horeis, Andrea Jagla, Linda Symsyk, Thelma Wheatley, Eleanor Woods, Susan Zalepa, and I were re-elected to the Executive for the 2015-2016 term, and I am delighted to welcome two new Executive members, Judith Kidd and Sydney Reimer, who were elected for the first time. Also, Maureen Shortt and Evelyn Milligan were re-elected as auditors. Thank you to Jack Slaughter for chairing the elections on short notice.

I want to thank all these people who have agreed to serve the Society for the coming year, and I want to thank Charles Cameron who is leaving the Executive for personal reasons after 15 years of dedicated service, which was recognized this year by a Volunteer Service Award from the Ontario Government.

We have a very strong Executive team, and I am requesting that you continue to give them your whole-hearted support. At the same time, I need to bring to your attention the following issues which need to be addressed promptly in order to ensure the ongoing successful operations of the Society:

<u>Secretary</u>: Andrea Jagla has served faithfully for seven years as the Society's secretary. I am pleased that Andrea will be staying on as a member of the Archives Team, but she has submitted her resignation as Secretary, effective this month. As in many organizations, the position of Secretary is one of the key roles spelled out in the Society's Constitution and By-Laws. The principal duties of this position involve recording minutes of the monthly members' meetings, the monthly Executive meetings, and the AGM.

**<u>Refreshments Coordinator</u>**: For the past programme year, Thelma Wheatley and Marjorie Horeis have jointly managed the meeting refreshments. We are anticipating that both ladies will be able to continue to serve on the Executive, but Marjorie has had to resign from the Refreshments Coordinator job for personal reasons, and Thelma has given notice that she will be unable to continue in this role after December. Ideally, we would like to find a person who could assist Thelma in November and December, and then take over the job in the New Year. Duties (many of which are normally delegated to helpers) involve arranging for the provision of food and supplies, setting up the refreshments table, making and pouring tea and coffee, cleaning up after the meetings, and managing donations and expenses.

**President:** I took on the position of President on an emergency basis in the spring of 2012, when my predecessor resigned very suddenly and unexpectedly. One of my first tasks involved building a new Executive, essentially from the ground up, and I am most grateful for the support I have received from my Executive team over the past 3½ years. At the October 2014 AGM (and again in 2015), I announced my intention to step down as soon as a suitable replacement can be found. I also made a commitment that I will be available to provide any coaching and support that my replacement may require. The President acts as the CEO of the organization, and he/she normally chairs the monthly members' meetings and Executive meetings. We have prepared a list of the President's principal duties, and we would be pleased to share that list with anyone who is interested in knowing more of what the job entails.

We are a volunteer organization, and we can always use more help and fresh ideas. In addition to filling the jobs listed above, we are also happy to welcome people on-board as "Executive members without portfolio", who may be called upon to participate in specific initiatives from time to time. Attendance at monthly Executive meetings is desirable, but not mandatory. # <u>Future Events</u>

**October 4 to November 7, 2015, Fort York Visitor Centre:** Magna Carta: Law, Liberty & Legacy: Centuries of history coming to Toronto!! This year marks the 800th anniversary of King John of England putting his royal seal on the Magna Carta (meaning "The Great Charter") in 1215. The Magna Carta and its companion document, the Charter of the Forest, set the groundwork for many concepts defining democratic life today in Canada, the United Kingdom, the United States and many other countries. As symbols of justice, they act as reminders that those who govern do so only by the consent of the people. Over centuries, the principles of Magna Carta influenced many other significant documents including the United States Bill of Rights (1791), the British North America Act (1867), the United Nations Universal Declaration of Human Rights (1948), and Canada's Charter of Rights and Freedoms (1982). See these remarkable historical documents and a fascinating exhibition that explains their history and importance as well as an exhibit highlighting persons and events in Toronto who reflected the ideals of Magna Carta. Adult \$20, Senior \$15, Youth/Child \$10.
